### Scarborough Winter Tennis Club Rules and Regulations

1. Members can book six days in advance by telephone. When calling Monday-Friday, phone line (416) 396-4042 is open from 7:00 am for Prime Time & 8:15 am for Non-Prime Time bookings. When calling Saturday or Sunday, phone lines open at 9:15 am for Prime Time and Non-Prime Time bookings. During these times, phone-in bookings will take immediate priority over any and all on-site requests for court time. (Members may ask to be placed on a waiting list in the event the time requested is unavailable).
2. There are no block bookings except for organised events approved by the Executives.
3. Members can only book one court per call. When playing Singles, (i.e., 2 players) the maximum booking is one court for two hours per day. When playing Doubles, (i.e., 4 players) the maximum booking is one court for two hours per day. Court booking records will be frequently and consciously reviewed to ensure the above Rule is strictly observed. The equitable and reasonable availability of court time for ALL the members is an inviolate tenet of the Club.
4. Members may play no more than 2 hrs Singles or 2 hrs Doubles per day.
5. Members are allowed to bring guests for a guest fee per person per court. Members may bring a guest twice a month and no guest may play more than twice a month. Guests must be accompanied with member, sign in and if requested, show photo identification. **The member who booked the court is responsible for ensuring guests sign in and payment of guest fee; failure to do so will result in a fine of \$30.00 to the member.** \_\_\_\_\_ (initial) Guest card will be issued to members on request.
6. When playing Doubles, a minimum of two people must be members; when playing Singles, one person must be a member.
7. **Cancellation of booked courts must be done at least 48 hours before scheduled court booking. Failure to give the full 48 hr will result in a cancellation fee of \$ 6.50** \_\_\_\_\_ (initial)
8. "No Show" court bookings must still be paid in full; failure to pay will result in the Member being charged for the court by the City of Toronto. \_\_\_\_\_ (initial)
9. Memberships are non-transferrable and non-refundable. You cannot share your membership tag or membership number with others for booking privileges or court access. \_\_\_\_\_ (initial)
10. Members must have valid club membership key tag. The City of Toronto issues membership tags (initially at no cost to the member). Photo must be taken to complete registration process and key tag issued. In the event of loss, members are to notify City of Toronto Staff who will re-issue a replacement at a cost of \$10.00 to the member. \_\_\_\_\_ (initial)
11. Members MUST scan their ID tags on arrival. Misrepresentation of SWTC membership key tag is a serious infraction.
12. Fees Must Be Paid In Full Before Using The Court. Individual/Partial Payments Will Not Be Accepted.
13. No Spectators Are Allowed On The Court At Any Time.
14. Only 3 balls are permitted on court except for where Rule #15 takes effect.
15. The general use of a ball hopper/machine is restricted to the Club Pro. The Executives must approve all other uses of the ball hopper/machine, without exception. Members who require the use of a ball hopper/machine must apply to the Executives in writing and if granted, its use will be restricted to Courts #1 and #4 in the building and Courts #6-#10 in the bubble. Ball hopper/machine is for personal use or with direct family member only. Member must notify staff regarding the user of ball hopper/ball machine at check in. Member to provide proof of authorization upon request.
16. Appropriate tennis etiquette and attire are required at all times. It includes but is not limited to: not using a cell phone on the courts; quickly passing balls back to the other courts when a point is over; quiet discussions in the viewing area and on the courts; no playing or running around in the viewing area; wear proper court shoes; DO NOT interrupt games on courts. Wait until a point is over to walk past a court through the back to access other courts etc.
17. Tennis instruction not authorised in writing by the Executive is strictly prohibited. This includes any instruction from viewing areas adjacent to the courts.

**The Executive may suspend or revoke membership in the event of any Club Rule abuses. At the instance of the first Rule violation the member in question will be verbally notified, cautioned and a record made of the incident by the Executives. The Executives will advise all further cautions/notices of violations to the member in writing. Please note there will be no refund given if membership is revoked.**

I have hereby read and understood the above-mentioned rules and regulations and shall abide to them throughout the SWTC season.
